Dear Mr. Elsherif, Thank you for your recent email inquiry.

Please be advised that the Board does not provide preapproval for any continuing professional competency activities, courses or providers. There is no option for applying for preapproval of any continuing professional competency activity.

Section 4.5 of the recently amended Engineer, Land Surveyor and Geologist Registration Law (Act) requires that continuing professional competency obtained by a licensee should maintain, improve or expand skills and knowledge obtained prior to initial licensure, including law and ethics applicable to the profession, or develop new and relevant skills and knowledge. No credit shall be given for a course in practice building or office management.

Providers wishing to offer continuing professional competency activities that allow licensee's to earn acceptable PDH, must comply with the requirements of section 4.5 of the act, by providing continuing professional competency activities; which are relevant to professional practice, that maintain, improve or expand skills and knowledge obtained prior to initial licensure, including law and ethics applicable to the profession, or develop new and relevant skills and knowledge.
